Howdy. I just wanted to give you an update on Fate. I took Justin Weiss, Ryan Wells, Susie? and a new planner, on a tour of Addison Circle yesterday. I wanted them to experience a 20 year old urban, mixed use development that was started from scratch and was greenfield before the plan was formulated. There have been several comments from Fate elected officials about "sure it looks great when they build it but what will it look like in 10 years/20 years?". Addison Circle, in my mind, is a perfect answer and they were very impressed! Staff will be taking P&Z and Council on a bus tour later this month and they are scheduled to visit Waters Creek, Lone Star Ranch and The Canals. They may now go to Addison Circle as well. Staff is trying to provide enough amo for their city officials to overcome objections by residents. Justin suggested that we have another work session with them after their tour. I think that's a great idea.

Timing-wise, Justin suggested we wait to submit anything until after the February 18 filing date to see if the incumbents will have challengers. If not we can move forward. If there are contested races we should wait until after the election so we are not a contested issue in the political process.
